Thursday, March 6, 2025 @ 6:00 p.m. Location – Wascott Town Hall

- 1) <u>Call to Order/Roll Call—</u> The meeting was called to order by Wascott Chair Chuck Youngquist at 6:00 p.m. Roll call—Board members present from Wascott—Chair Youngquist, Supv Liautaud. Absent Supv Christensen. Board members present from Gordon—Chair Knutson, Supv Golembiewski. Supv Eagle. Also present were Wascott Town Clerk/Treasurer Atkinson, Gordon Town Clerk Wohlbier and 5 guests.
- 2) Pledge of Allegiance was recited.
- 3) <u>Approval of Agenda-</u> A Golembiewski/Liautaud motion to approve the agenda; motion carried.
- 4) <u>Approval of Meeting Minutes</u> A Eagle/Golembiewski motion to approve the December 18, 2024 minutes correcting the minutes to indicate Supv Eagle was not present at the meeting; motion carried.
- 5) Public Comments Steve Trainor commented the T/S attendants continue to do a great job for the Town. Kelly King asked why they can't get EMS financial reports early so as to review. Chair Youngquist explained the reports are only reviewed at a meeting of the Jt. Board and not the service as a whole. Les Chandler commented he felt there were contractors dumping at the T/S who shouldn't be. What about using the Private Contractor Agreement. Also, how should pricing be determined for loads of various sizes.
