- b) <u>Douglas County Forestry Department and Gordon Historical Society use of Transfer Station</u> A Youngquist/Christensen motion the DC Forestry Department will pay an annual fee of \$300/yr for use of the Transfer Station; Roll Call Vote Eagle, yes; Germann, yes; Youngquist, yes; Christensen, yes; Liautaud, yes; motion carried. Chair Golembiewski abstained.
 - A Eagle/Golembiewski motion to grant the Gordon-Wascott Historical Society use of the Transfer Station, with no charge; motion carried.
- c) Purchase of Shipping Container- A Golembiewski/Christensen motion to purchase a 20' container not to exceed a cost of \$3,500 and delivered to the Transfer Station; motion carried. Unit will serve the purpose of collection of electronics, computers, tv's, etc.
 - An Eagle/Golembiewski motion to charge 25% over the cost of what the disposal costs would be; motion carried.
