**WHEREAS**, the Town of Gordon Board has determined that it is prudent to create a Fee Schedule to provide efficiency, economy and uniformity in establishing and adjusting the fees charged by the Town of Gordon as enumerated throughout the ordinances and resolutions adopted by the Town of Gordon into one abbreviated schedule, and


**WHEREAS**, the fees set forth in the Fee Schedule may be added to or amended from time to time by adoption of a Resolution, and


**WHEREAS**, the Town Board shall review the Fee Schedule on at least an annual basis for the purposes of adjusting and updating the fees charged by the Town, and any amendments or additions thereto may be made by Resolution, and

**WHEREAS**, the fees set forth in the Fee Schedule shall supersede any fee established elsewhere in the Town's ordinances and resolutions for the same charge. If a fee is set forth elsewhere in a Town of Gordon's ordinance or via a resolution, and there is no corresponding fee set forth in the attached Fee Schedule, the fee set forth elsewhere in the ordinance or the resolution shall control until such time as a fee for the same charge is established in the Fee Schedule.

**THEREFORE BE IT RESOLVED** that the Town of Gordon Board approves the following Fee Schedule as defined in the attached schedule and shall be effective upon passage of this resolution and posting of this resolution.

<b>BUILDING PERMITS</b>	
Building Information Permit (non-refundable) <i>Fee is doubled if work begins before permit is issued.</i>	\$25

<b>DRIVEWAY FEES</b>	
Driveway Access Permit (non-refundable) <i>Fee is doubled if work begins before permit is issued.</i>	\$50
<b>PUBLIC RECORDS FEES</b>	
Copy fees (includes costs of a computer run) <i>An authority has the discretion to provide requested records for free or at a reduced charge.</i>	\$0.25 per page
Location costs -- only actual, necessary and direct location costs. Only charged if costs total \$50.00 or more.	\$35 per hour
Other costs for photographs, transcription fees, mailing and shipping, audio and video files	Actual, necessary and direct costs
Redaction costs	No charge
Any charge for public records over \$5.00 must be paid before receiving materials.

“Class A” Retail Liquor License (Including Wine), off-premises	\$100 per year*
Class "A" Fermented Malt Beverage (Beer) Retailer’s License , off-premises	\$100 per year*
“Class B” Retail Liquor License, on-premises and off-premises.	\$200 per year*
Class “B” Fermented Malt Beverage (Beer) Retailer’s License, on-premises or off-premises	\$100 per year*
“Class C” Wine License, on-premises	\$100 per year*
<p><i>* When a new “Class A”, “Class B”, “Class C”, Class “A” or Class “B” license is issued proration of the annual fees is required on the basis of the number of months or fractions of months remaining in the licensing year.</i></p>

Application Fee for Retail Alcohol Beverage Licenses (Includes Publication and Background Check)	\$50 per year
Temporary “Class B” Wine (Picnic License) or Temporary Class “B” Beer License (“Picnic License”)	\$10 per event
Operator’s (Bartender’s) License (valid up to 2 years, expires on June 30)	\$10
Provisional Operator’s License (up to 60 days)	\$15
